Applications are invited online only through One Time Registration from qualified candidates for appointment in the undermentioned post in Kerala Government Service. Before applying for the post candidates Should register as per One Time Registration Scheme through the official website of Kerala Public Service Commission.

1. **Department** : Medical Education Service
2. **Name of Post** : Assistant Professor in Medical Oncology
3. **Scale of pay** : As per UGC Norms.
4. **Number of** : 09 (Nine)

vacancies

The above vacancies are now in existence. The Ranked list published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the vacancies reported to the Commission during the period of currency of the list.

Those who are appointed in the post should serve four(4)years during first ten(10)years of their service (including the period of training) anywhere in India or any other foreign country under defence service or services connected with defence, if required. Differently abled candidates and those who have completed forty five (45) years of age are exempted from the above Compulsory Military Service.

5. **Method of appointment** : Direct Recruitment.
6. **Age limit** : 22-45; Only candidates born between 02.01.1976 and 01.01.1999 (both dates included) are eligible to apply

for the post. Candidates from other Backward Communities, Scheduled Castes and Scheduled Tribe are eligible for usual age relaxation. The concessions in upper age limits are available subject to the conditions that the maximum age limit shall in no case exceed 50(Fifty) Years.

(For other conditions regarding the age relaxation please see part 2 of the General Conditions)

- 7. Qualifications** :
1. DM/DNB in Medical Oncology.
 2. In the absence of the above, MD/DNB in General Medicine/Radio Therapy/Paediatrics with two years special training in Medical Oncology.
 3. Registration with Travancore Cochin Medical Council/ Medical council of India.

Other conditions:

(i) Three Years teaching experience in the department of Medical Oncology as Resident in a recognized Medical College.

(ii) One year teaching experience after acquiring Post Graduate Degree. In the absence of candidates possessing one year teaching experience as Senior Resident, those who do not possess senior residency, but possess all the other qualifications prescribed for the post shall also be considered.

Note : 1. Rule 10 a(ii)of Part II KS & SSR is applicable.

2. The post Graduate study period for Medical subjects will be considered as teaching experience for appointment as Assistant Professor Provided the candidates have undergone Residency Programme during the Post Graduate Course period and in the case of candidates who have passed the Post Graduate course without

undergoing residency programme a certificate shall be produced by the candidate from the Principal of the College to the effect that the candidate has got teaching/clinical work experience during the Post Graduate Course period.

3. Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
4. In the case of difference in original Caste/Community claimed in the application and that entered in the SSLC book, the candidate shall produce a Gazette notification in this regard, along with Non Creamy layer Certificate / Community Certificate at the time of certificate verification.

8. Mode of Submitting applications:

(a) Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to apply for the post. The photograph uploaded should be one taken after 31.12.2011. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep**

a printout or soft copy of the online application for future reference. Candidates can take the print out of the application by clicking on the link 'My applications' in their profile. All correspondence with the Commission, regarding the application should be accompanied with the print out of the application. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original Documents to prove qualification, experience, age, Community etc. have to be produced as and when called for.

(b) If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.

(c) Appropriate disciplinary action as per Rules of Procedure Rule 22 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.

(d) Candidates who have AADHAAR card should add AADHAAR card as ID proof in their profile.
