Notes :

- (i) Separate Ranked list will be prepared for each district in pursuance of this notification. The Ranked list thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against aforesaid vacancies and also against the vacancies, if any, reported during the currency of the lists. In case no candidate is advised from the ranked list till expiry of the period of three years, the duration of the Ranked list shall be extended for a

further period of one year or till at least one candidate is advised from the list whichever is earlier.

- (ii) Candidates should submit the application for this post to the concerned district office and should note the name of that district against the relevant column in the applications. Applications should not be sent to more than one district in response to this notification. If applications are sent contrary to the above direction and if he/she is selected his/her name will be removed from the ranked lists and disciplinary action will be taken against him/her.
- (iii) The selection in pursuance of the notification will be made on a revenue district basis, subject to the special conditions laid down in G.O. (Ms)No.154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS)No.4/61/PD, dated 02.1.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

- 5 Method of appointment : Direct Recruitment
- 6 Age : 18-36. Only candidates born between 02.01.1984 and 01.01.2002 (both dates included) are eligible to apply for this post. Usual age relaxation will be given to SC/ST & Other backward Communities.

Note :- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification.

7 Qualifications :-

SSLC Pass or its equivalent.

- 1.) Rule 10a(ii) of KS&SSR Part II is applicable for selection to this post.
 - 2.) Candidates claiming equivalent qualification should produce relevant Government orders during OTR verification to prove that the qualification claimed is equivalent to the prescribed qualification for the post.
 - 3.) In the case of difference in original Caste/Community claimed in the application and that entered in SSLC Book, the candidate shall produce a gazette notification in this regard, along with Non Creamy Layer Certificate/Community Certificate at the time of certificate verification.

8 Mode of submitting applications:-

Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have already registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the Apply Now button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be one taken after 31.12.2010. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking the photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates can view the details in their profile by clicking the link 'Registration Card' in their profile. A print out of the same can be taken if needed. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, age, Community etc. have to be produced as and when called for. Candidates who have AADHAAR card should link their AADHAAR Card as I.D Proof in their profile.

- 9 Last date of receipt of applications :**21/10/2020** Wednesday up to 12 midnight.
- 10 If written/OMR/Online Test is conducted as part of this selection, candidate shall submit a confirmation for writing the examination through their One Time Registration Profile. Such candidate alone can generate and download the admission tickets in the last 15 days till the date of test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. Appropriate disciplinary action as per Rule 22 of the KPSC Rules of procedure will be taken against those candidates who submit application for the post with false claims of possession of prescribed qualification etc and give confirmation for the examination irrespective of the fact that they have appeared or not for the examination. The periods regarding the submission of confirmation and the availability of admission tickets will be published in the Examination calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone registered in it. Candidates who have downloaded the admission ticket will alone be permitted to attend the examination.
