As per G.O.(P)No.1/13/SJD dtd. 03.01.2013, 3% vacancies are reserved for Differently Abled candidates. The recruitment of the Differently Abled candidates will be subject to the orders regarding recruitment to various Company/Corporation/Board/Societies made by them from time to time.

Note:- (i) The number of candidates to be included in the Short List/Probability List of the above post will be decided as per the availability of admitted applications.

- (ii) The list of selected candidates published by the Commission in pursuance to this Notification shall remain in force for a minimum period of one year and a maximum period of three years provided that list will not continue to be in force if a new Ranked List after the minimum period of one year is published. Candidates will be advised against the vacancies reported for the post having the scale of pay as prescribed by the Company/Corporation/Boards from the Ranked List strictly in accordance with the order of receipt of vacancies in the office of the Commission and in accordance with the rules of reservation and rotation followed by the Commission. Candidates will not have the right to choose a particular company/corporation/board or scale of pay.
- (iii) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidates to the above post, if it is subsequently found that such advise was made under some mistake. On such cancellation the appointing authority shall terminate the service of candidate, provided that, the cancellation of advice for

appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made with in the period of probation or 240 days from the date of joining duty whichever is earlier.

6 Age : 18-36 "Only candidates born between 2.1.1981 and 1.1.1999 (both dates included) are eligible to apply for this post ." Other Backward Communities and SC/ST candidates are eligible for usual age

The provisional hands working in the above concern will given age Note:relaxation to the extent of their provisional service put in subject to a maximum of Five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission.
