Applications are invited Online only by **ONE TIME REGISTRATION** from qualified candidates for selection to the under mentioned post in the Kerala Government Service.

1. **Department** : Public Works/Irrigation
2. **Name of Post** : Overseer/Draftsman Grade I (Electrical)
3. **Scale of pay** : ₹ 26500-56700/-
4. **Number of vacancies** : 04 (Four)

The above vacancies are now in existence. The list of selected candidates published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the vacancies noted above and also against the vacancies if any, reported to the Commission in writing during the currency of the list.

- 5 **Method of appointment** : Direct Recruitment
- 6 **Age limit** : 19-37, only candidates born between 01/01/2001 and 02/01/1983 (both dates included) are eligible to apply for this post with usual age relaxation to Scheduled Caste / Scheduled Tribe and Other Backward Community .
(For other conditions regarding age relaxation please see Para 2 of the General Conditions)

7 **Qualifications:-**

- I. (a) Minimum General qualification of SSLC standard
AND
(b) Diploma in Electrical Engineering of a recognized Institution after three years course of study.

In the absence of candidates possessing the qualifications mentioned in (b) above, a Certificate in Electrical Engineering, issued after a course of 2 years from any one of the Technical Schools, recognized by Government and 5 years experience under the Kerala State Electricity Board or in an Electricity undertaking recognized by the Government. The experience prescribed shall be one acquired after

obtaining the basic academic or other qualification.

- Note I For candidates belonging to Scheduled castes and Scheduled Tribe, the requirement of experience in lieu of the Diploma qualification shall not be insisted upon. Such candidates shall be given training for six months during the period of probation after appointment to the post
- Note II The Kerala Government Certificate Examination in Electrical Engineering (2 Years course) shall be treated as alternative qualification in lieu of Certificate in Electrical Engineering after undergoing a course of study of 2 years in a recognized institution.
- Note III “ Certificate in Electrical Engineering after a course of study of 2 years from an institution recognized by the Government of Kerala or from any of the Technical Schools recognized by the Government” mentioned shall be certificate issued by the Commissioner for Government examination on behalf of the State Board of Technical Examination after undergoing a course for 2 years duration.
- Note IV Rule 10(a) (ii) of Part II of KS & SSR is applicable.
- Note V Applications of candidates who have claimed qualifications equivalent to those prescribed in the Gazette Notification for the post will be considered equivalent only if they produce Government Order to prove equivalency at the time of verification.
- Note VI In the case of difference in original Caste/Community claimed in the application and that entered in SSLC Book, the candidates shall produce a gazette notification in this regard, along with Non-Creamy Layer Certificate/ Community Certificate at the time of certificate verification

8 Mode of submitting applications:-

a) Candidates must register as per “ONE TIME REGISTRATION” with the official Website of Kerala Public Service Commission ‘www.keralapsc.gov.in’ before applying for the post. Candidates who have already registered can apply by logging on to their profile using their User -ID and password. Candidates must click on the Apply Now button of the respective posts in the Notification Link to apply for the post. The Photograph uploaded should be taken after 31.12.2010 . Name of the candidate and the date of taking photograph should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the user ID for further communication with the Commission. Application once submitted is received as provisional and the details cannot be deleted or altered after submission.

The application will be summarily rejected if noncompliance with the notification is found in due course of processing . Original documents to prove qualification,experience, age, community etc. have to be produced as and when called for.

b) If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profiles. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the examination calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.

c) Appropriate disciplinary action as per Rules of Procedure Rule 22 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.

d) Candidates who have AADHAAR card should add AADHAAR Card as I.D Proof in their profile.
