**Note ii:-** In the case of difference in original caste/community claimed in the applications and that entered in SSLC book, the candidate shall produce a gazette notification in this regard along with Non creamy layer certificate/caste certificate issued by competent revenue authority, at the time of verification.

**Note iii:-** Applications should not be sent to more than one district in response to this notification. If applications are sent contrary to the above direction, and if she is selected, her name will be removed from the Ranked List and disciplinary action will be taken against her.

**Note iv:** Separate Ranked Lists will be prepared for each District in pursuance of this notification. The Ranked list thus prepared and published by the Commission, shall cease to be in force after one year

from the date of finalization of the Ranked List (as per notification AV(2) 2376/14/GW dated 04.04.2016, Extra Ordinary Gazette dated 15.04.2016). Candidates will be advised from the said list against the vacancies that may be reported to the Commission in writing during the period of currency of the Ranked List.

**Note v:-** The selection in pursuance of the notification will be made on District basis subject to the special conditions laid down in G.O (Ms)No.154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another District unless he completes five years continuous service from the date of commencement of service in the former District. Even if transfer is allowed after five years, it will be subject to the rules in G.O (Ms)No.4/61/PD, dated 02.01.1961.

5. **Method of Recruitment** : **Direct Recruitment (From Women Candidates Only).**  
*Note: Differently Abled candidates are not eligible to apply for this post*
6. **Age Limit** : 18-26.  
Only candidates born between 02.01.1994 and 01.01.2002 (both dates included) are eligible to apply for this post.  
  
Other Backward Communities, Scheduled caste converts and SC/ST candidates are eligible for usual age relaxation as provided under sub rule (c) of the Rule 10 of the general rules. Other conditions regarding the age relaxation are not applicable to this post.

  - b. Must not be less than 152 cms in height (without footwear)

8. **Bond:-** A Person appointed to the post of Fire woman shall execute a bond (as in Annexure I – GO(Ms)No. 128/19/Home dated 21.08.2019) , binding herself to serve in the force for a minimum period of 7 years after the completion of training and to pay to Government an amount of Rs. 50,000 (Rupees Fifty Thousand Only) , in case of failure to serve in the force for the said period.

Provided that in case the bounden fails to complete the obligatory service of ..... Years after her joining duty on completion of training the bounden shall pay only the proportionate amount equal to the portion of the shortfall of service to the period of ..... years together with a sum of Rs. .... 9. **Probation:-**Every Person appointed to the post shall from the date on which she reported for duty after completing the training and examinations prescribed be on probation for a total period of two years on duty within a continous period of three years of service.

## 10. TRAINING

- i. Training for a period of six months in the State Fire Service Training School or in any other institution as may be fixed and a pass in the examination in the subjects prescribed for the course

**Note:** Seniority among persons who have qualified in the test at the Fire Service Institute shall be determined on the basis of effective advice of the Kerala Public Service Commission and they shall be appointed to the service on the basis of seniority list only after the completion of training.

- ii. After the above training, six months practical training at the Fire Station and pass in the Examination in the subject prescribed for the course.

**Note:** A written and practical test shall be conducted during the last fortnight of the period of training. Those who fail to qualify in either one or both tests shall have their training extended for a further period of one month, at the end of which they shall be tested again in the subjects in which they failed, the Director General of Fire and Rescue Services shall allow a third chance to pass the course to all recruits who fail at the re test. Those who failed to qualify themselves the above test shall be discharged from the service.

- iii. Person undergoing training shall be paid basic pay as stipend. The person who successfully complete the training shall be eligible for pay and allowance during the prescribed training period mentioned above, after she joins duty. The training period including final examination in the entry cadre shall be treated as duty for all purposes.

## 11. **Mode of submitting Applications:**

Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)' before applying for the post. Candidates who have registered shall apply by logging in to their profile using their User- ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification link to apply for a post. The photograph uploaded should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading of the photograph. There is no change in other instructions regarding the uploading of photograph. No application fee is required. Candidates can view the details in their profile by clicking the link Registration Card in their profile. A printout of the same can be taken if needed. Candidates are responsible for the correctness of the personal information and secrecy of password. Before final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the commission. Applications once submitted is provisional and cannot be deleted or altered after submission. Applications will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove

Qualification, experience, community, age etc. have to be produced as and when called for.

**12.** Appropriate Disciplinary action as per Rules of procedure Rule 22 will be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc and submit confirmation for writing examination irrespective of whether they are present or absent for the examination.

The applications of candidate who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of admission tickets will be published in the examination calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.
