Applications are invited online only by **ONE TIME REGISTRATION** scheme from qualified candidates belonging to SCCC Community in the state of Kerala for selection to the under mentioned post in Kerala Government Service.

1. **Department** : Medical Education
2. **Name of Post** : Dental Hygienist Grade II
3. **Scale of Pay** : ₹ 22200-48000
4. **Number of vacancy** : SCCC – 1 (One)

The above vacancy is now in existence. The Ranked List published as per this notification will be valid until a candidate is advised and appointed against the vacancy earmarked for the SCCC community as unfilled due to paucity of candidates during the currency of the Ranked List, published on 30.12.2008 for the post (Cat.No.114/2007) This is the VII<sup>th</sup> NCA Notification published due to the non-availability of candidates for the post as per notifications I<sup>st</sup> NCA dated 30.12.2009 (Category No. 481/09), II<sup>nd</sup> NCA dated 30.12.2010 (Category No.430/2010) III<sup>rd</sup> NCA dated 30.04.2012 (Cat.No.151/12), IV<sup>th</sup> NCA dated 17.09.2015 (Cat.No.262/15), V<sup>th</sup> NCA dated 30.12.2016 (Cat.No. 500/16) and VI<sup>th</sup> NCA dated 24.09.2018 (Cat.No. 169/2018).

5. **Method of appointment** : Direct Recruitment (from candidates belonging to SCCC community only)

**Note:-** Applications submitted by candidates belonging to the community other than SCCC will be summarily rejected. No individual rejection memo will be issued to them.

6. **Age Limit** :- 18-39 : (Only candidates born between 02.01.1981 and 01.01.2002 (both dates included) are eligible to apply for the post. (including the relaxation as per Para 2(i) of the General Conditions) (For other conditions regarding age relaxation please see para 2 of the General Conditions except Para 2(i))

**Note:-** Candidates who were adult members of SC community converted to Christianity (SCCC) and their children are eligible for age relaxation up to 5 years in the upper age limit. Such candidates should be born between 02.01.1979 and 01.01.2002 (both dates included)

## 7. Qualifications:

- I Minimum General Educational qualification of Pre-Degree or +2
- II Pass in Dental Hygienist Course (Diploma/Certificate Course) Conducted in the Dental College approved by the Dental Council of India.
- III Registration with State Dental Council.

In the absence of candidates with the above qualification, candidates with the following qualifications as per mother notification will be considered.

- 1. Minimum General Educational qualification of Pre - Degree or +2.
- 2. Pass in Dental Hygienist Course conducted in Dental College.

- Note :
- 1 Rule 10 a (ii) of part II KS&SSR is applicable.
  - 2 Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
  - 3 In the case of difference in original Caste/Community claimed in the application and that entered in the SSLC book, the candidate shall produce a Gazette notification in this regard, along with Non Creamy layer Certificate/ Community Certificate at the time of certificate verification.

## 8. **Mode of submitting Application:-**

- a) Candidates must register as per 'ONE TIME REGISTRATION' with the official Website of Kerala Public Service Commission '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)' before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link **Registration Card** in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, Experience, Community, age etc. have to be produced as and when called for.
- b) If a Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the

Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.

- c) Appropriate disciplinary action as per Rules of Procedure Rule 22 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.
- d) Candidates who have AADHAAR Card should add AADHAAR Card as ID Proof in their profile.
