Applications are invited from qualified **Scheduled Caste/Scheduled Tribe** candidates of Kerala State for selection to the following post. Applications must be submitted online through the official website of the Commission after One Time Registration. Candidates who have already registered can apply through their profile. The photo uploaded through One Time Registration should be the one taken after 31.12.2012 and also bear the name of candidate and the date of photo taken should be recorded in the bottom of the photograph. The uploaded photo will be having a validity of ten years from the date of photograph taken.

**Note:** The above vacancy is now in existence. The Ranked list of selected candidates published by the Commission in response to this notification shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list is published after the expiry of the minimum period of one year. Recruitment will be made for the above vacancy and also for the vacancies reported for Special Recruitment from Scheduled Caste/Scheduled Tribe during the pendency of the list. Candidates against vacancies exclusively reported for Scheduled Tribes will also be advised from this list and only in the absence of Scheduled Tribe candidates in this list that fresh notification for Scheduled Tribes for vacancies reserved exclusively for them will be issued.

- 5 Method of Appointment** : Direct Recruitment (Special Recruitment for Scheduled Caste/Scheduled Tribes only).

**Note:-** Applications received from candidates other than Scheduled Caste/ Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

- 6 Age** : 20-50,  
Only Candidates born between 02.01.1972 and 01.01.2002 (both dates included) are eligible to apply for this post. No other age relaxation will be allowed.

**7 Qualifications:**

- (i) A Post Graduate Degree in Ayurveda in the concerned subject from any of the Universities in Kerala or from any other University recognised by any of the Universities in Kerala.
- (ii) Permanent 'A' Class Registration with Travancore – Cochin Medical Council (Council of Indigenous Medicine).

**Note:-** 1 Post graduate degree in the concerned subject has been made compulsory for appointment by direct recruitment to the post of Assistant Professor.

- 2 If post-graduate holders of any subject are not available, post-graduate qualification prescribed by Central Council of Indian Medicine shall be admissible for that subject from time to time.
- 3 Rule 10(a)(ii) of part II of KS&SSR is applicable for this selection.
- 4 Candidates who claim equivalent qualification instead of qualification mentioned in the notification should produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
- 5 If the caste of the candidate is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce community certificate issued from the revenue authority concerned and the Gazette Notification to prove the same at the time of certificate verification.

**8 Probation:**

Every Person appointed to this post shall from the date on which he joins duty be on Probation for a total period of two years on duty within a continuous period of three years.

**9 Method of submitting Applications**

(A) Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken after 31.12.2012. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. **But the candidates who register One Time Registration Profile after 01/01/2022 should upload photograph taken within 6 months.** There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, Community etc. have to be produced as and when called for.

(B) If written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.

(C) Candidates who erroneously claim qualification, experience etc and attend or abstain from attending the examination after providing confirmation are liable for disciplinary action as stipulated in Rule 22 of KPSC Rules of Procedure 1976.

D) Those who have Aadhaar Card should add Aadhaar Card as ID Proof in their profile
